WAITING) (CONSOLIDATION) ORDER 1996 AMENDMENT ORDER 2024 No.1 (UCKFIELD
BUS STATION)

East Sussex County Council, in exercise of their powers under Sections 1(1), 2(1) to (4), 3(2), 4(2), and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, the Road Traffic Act 1991, as amended, Part 6 of the Traffic Management Act 2004, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. When this Order comes into effect
 - (a) The East Sussex (Roads in Uckfield)(Prohibition and Restriction of Waiting) (Consolidation) Order 1996, as amended, shall have effect except as hereinafter contained.

Schedule One, No Waiting At Any Time, that this Schedule be amended as follows:

1. Delete item 4 (a) as follows:

4	Bell Lane	(a)	East Side		From its junction with Bell Farm Road, southwards for a distance of 32 metres.

2. Replace it with item 4 (a) (i) and (ii) as follows:

4	Bell Lane	(a)	East Side	i	From its junction with Bell Farm Road, southwards to its junction with Bell Walk.
4	Bell Lane	(a)	East Side	ii	From its junction with Bell Walk, southwards for a distance of 15 metres.

3. Insert item 4A as follows:

4A	Bell Walk		Both Sides		For its entire length.

3. Insert item 27 as follows:

27	Unnamed road between Bell Lane and Bell Walk (Bus Station)	(a)	West Side	i	From its junction with Bell Lane, southwards for a distance of 12 metres.

27	Unnamed road between Bell Lane and Bell Walk (Bus Station)	(b)	East Side		For its entire length.
27	Unnamed road between Bell Lane and Bell Walk (Bus Station)	(c)	Centre Island (both sides)		For its entire length.

3. Insert item 28 as follows:

28	Unnamed road south of Bell Walk		Both Sides	From its junction with Bell Walk, southwards for a distance of 7 metres.
