COMPULSORY PURCHASE ORDER 2023

THE HIGHWAYS ACT 1980

AND

THE ACQUISITION OF LAND ACT 1981

The East Sussex County Council (in this order called "the acquiring authority") makes the following order:

- 1. Subject to the provisions of this order, the acquiring authority is under sections 239, 240, 246, 249, 250 and 260 of the Highways Act 1980, hereby authorised to purchase compulsorily the land and new rights over the land described in paragraph 2 for the purposes of:
 - the construction of a replacement bridge at the A259 over the Cuckmere River with a two lane bridge with footpath including re-profiling of the river and road bed embankments, alterations to access, provision of shared surface area and habitat creation;
 - the construction of other highways and improvement of existing highways in the vicinity of the route of the above mentioned highway in pursuance of the East Sussex County Council (Exceat Replacement Bridge A259 Eastbourne Road) (Classified Road) (Side Roads) Order 2023;
 - the provision of new means of access to premises in pursuance of the East Sussex County Council (Exceat Bridge Replacement A259 Eastbourne Road) (Classified Road) (Side Roads) Order 2023;
 - (iv) the diversion of watercourses and the carrying out of other works on watercourses in connection with the construction and improvement of highways and the provision of new means of access to premises as aforesaid;
 - (v) the use by the acquiring authority in connection with the construction and improvement of highways and the provision of new means of access to premises as aforesaid;

- (vi) the carrying out of drainage works in connection with the construction of the highways; and
- (vii) mitigating the adverse effect which the existence or use of the highways proposed to be constructed or improved will have on the surroundings thereof.

2.

- The land authorised to be purchased compulsorily under this Order is the land which is described in the Schedule hereto and is delineated and shown edged red and coloured pink on a map, prepared in duplicate, each sealed with the Common Seal of the acquiring authority and marked "Map referred to in East Sussex County Council (Exceat Bridge Replacement A259 Eastbourne Road) Compulsory Purchase Order 2023". One duplicate of the map is deposited in the offices of the acquiring authority and the other is deposited in the offices of the Secretary of State for Transport
- (2) The new rights to be purchased compulsorily over land under this Order are described in the Schedule and the land is coloured blue on the said map.
- 3. Parts II & III of Schedule 2 to the Acquisition of Land Act 1981 are hereby incorporated with this Order subject to the modifications that references in the said parts of the Schedule to "the undertaking" shall be construed as references to any building or work constructed or to be constructed on the land and pursuant to the new rights authorised to be compulsorily purchased under this Order.
